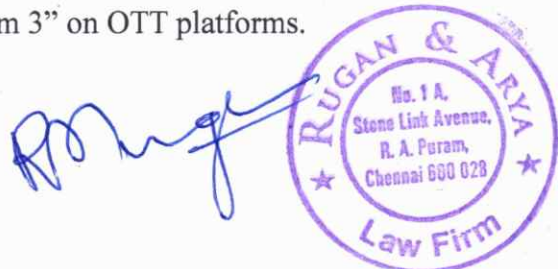

M/s. Rajkumar Theatres Pvt Ltd., have filed a suit, vide C.S. (COMM DIV) No.144 of 2026, before the Hon'ble High Court, Madras, against M.J.Antony, of Aashirvad Cinemas, Mr. Jeethu Joseph, M/s.Panorama Studio and M/s. Pen Studios, for a permanent injunction restraining them, their servants, agents, employees, assignees, licensees and every one claiming under or through them from infringing the exclusive Copyright of M/s. Rajkumar Theatres Pvt Ltd., by remaking and exploiting the said Film "Drishyam 3" in Telugu language, anywhere in the World;

In the above suit, the Plaintiff filed O.A.No.488 of 2026 for interim injunction restraining the defendants, their servants, agents, employees, assignees, licensees and every one claiming under or through the defendants from infringing the Plaintiff's exclusive Copyright of remaking and exploiting the subject film "Drishyam 3" in Telugu language, starring Mohanlal, Meena, etc., directed by Jeethu Joseph, by releasing the dubbed version of "Drishyam 3", in Telugu, anywhere in the World.

The Hon'ble High Court, in the above Application, granted today an injunction restraining the Respondents 1. M.J.Antony, of Aashirvad Cinemas, 2. Jeethu Joseph 3. M/s.Panorama Studio and 4. M/s. Pen Studios and their servants, agents, employees, assignees, licensees and every one claiming under or through the defendants from releasing or exploiting the Telugu dubbed version of the movie "Drishyam 3" on OTT platforms.
